**RESOLUTION OF THE BOARD OF DIRECTORS
MASAN MEATLIFE CORPORATION (“the Company”)**

THE BOARD OF DIRECTORS (“BOD”)

- Pursuant to the Law on Enterprises No. 59/2020/QH14 adopted by the National Assembly on 17 June 2020, as amended and supplemented by Law No. 76/2025/QH15 dated 17 June 2025;
- Pursuant to the Law on Securities No. 54/2019/QH14 adopted by the National Assembly on 26 November 2019, as amended and supplemented by Law No. 56/2024/QH15 dated 29 November 2024;
- Pursuant to the prevailing Charter of the Company, as amended and supplemented from time to time (“**the Charter**”);
- Pursuant to the Resolution of the 2026 Annual General Meeting of Shareholders of the Company No. 01/2026/NQ-ĐHĐCĐ dated April 24, 2026 (“**AGM Resolution**”); and
- Pursuant to the Minutes on Vote Counting of the Board of Directors' Written Opinions No. 08/2026/BBKP-HĐQT dated 01 June, 2026.

RESOLVED

Article 1: Approval of the implementation of the share issuance plan under the Employee Stock Ownership Plan (“ESOP”) in accordance with Article 8 of the AGM Resolution as follows:

- Share name: Shares of Masan MEATLife Corporation.
- Total number of outstanding shares of the Company: 340,316,858 shares.
- Expected ESOP shares: 4,792,571 shares, equivalent to 1.41% of the total outstanding shares of the Company.
- Share type: Ordinary shares.
- Par value: VND 10,000/share.
- Issuance price: VND 10,000/share.
- Source of issued shares: Newly issued shares.
- Eligible recipients: Employees of the Company and its subsidiaries who have demonstrated outstanding achievements, made exceptional contributions to the production and business activities of the Company and its subsidiaries, and generated long-term growth value for the Company and its subsidiaries.
- Allocation criteria and principles: As stipulated in the Regulation on the 2026 Employee Stock Ownership Plan.

- Principles and criteria for determining the number of shares allocated to each eligible participant: As stipulated in the Regulation on the 2026 Employee Stock Ownership Plan.
- Plan for handling unsubscribed shares: Upon expiry of the registration and payment period for share purchase, if employees do not subscribe for all the shares proposed to be issued, the unsubscribed shares shall not be offered for further sale, and only the actual subscribed shares shall be recorded.
- Implementation timeline: Within 2026 or the first four months of 2027, in compliance with applicable laws and information disclosure requirements.
- Transfer restriction: All shares issued under the ESOP Program shall be subject to a transfer restriction for a period of 01 year from the completion date of the issuance (being the completion date of collection of payment from employees).

Article 2: Approval of the plan to ensure the foreign ownership ratio compliance:

- The current maximum foreign ownership ratio of the Company is 100% of its charter capital.
- No foreign employees shall participate in the ESOP Program. Accordingly, the share issuance under the ESOP Program complies with the foreign ownership ratio of the Company in accordance with applicable laws.

Article 3: Approval of the plan for use of proceeds: The expected proceeds of VND 47,925,710,000 from the issuance shall be used to pay for employees' salaries, goods and raw materials, suppliers, short-term and long-term loans, and bond principal and interest.

Article 4: Authorizing Mr. Danny Le – Chairman of the Board of Directors, or Mr. Nguyen Anh Thi – Chief Executive Officer, with full authority to:

- decide on the implementation timing and prepare all dossiers to be submitted to competent authorities in relation to the share issuance under the ESOP Program;
- record the actual number of subscribed shares and refrain from further offering any unsubscribed shares (if any) in accordance with the principle set out in Article 1;
- execute contracts, agreements, and other documents related to the share issuance under the ESOP program;
- carry out necessary procedures for registration of the charter capital increase with the Ho Chi Minh City Department of Finance, registration of additional depository for the actual issued shares with the Vietnam Securities Depository and Clearing Corporation, and registration of additional trading for the actual issued shares with the Hanoi Stock Exchange;
- amend the Company's Charter in relation to the new charter capital based on the actual number of shares issued under the ESOP program;
- decide on the use of the proceeds from the issuance in accordance with the plan set out in Article 3;
- carry out all other necessary tasks to complete the issuance of new shares under the ESOP Program.



Article 5: The Chairman of the Board of Directors, the Chief Executive Officer, and the relevant individuals and departments of the Company shall be responsible for implementing this Resolution.

Article 6: This Resolution shall take effect from the date of signing./.

REGULATION ON THE EMPLOYEE STOCK OWNERSHIP PLAN (ESOP) 2026

0311224517

- The Employee Stock Ownership Plan (abbreviated as the “ESOP Program”) is implemented to provide employees of Masan MEATLife Corporation (the “Company” or “Masan MEATLife”) and its subsidiaries (who satisfy the eligibility criteria and conditions, which will be set out below) with the opportunity to share in the growth and success of the Company through the opportunity to own shares of the Company at a preferential price compared to the market price.

1. PURPOSE:

- To issue shares to employees of the Company and its subsidiaries under the Employee Stock Ownership Plan in recognition of their contributions to the Company and its subsidiaries over the past year, and to motivate employees to excellently fulfill their duties and maintain long-term commitment to the Company and its subsidiaries

2. LEGAL BASIC:

- The Law on Enterprises No. 59/2020/QH14 passed by the National Assembly on June 17, 2020, as amended and supplemented by Law No. 76/2025/QH15 dated June 17, 2025;

- The Law on Securities No. 54/2019/QH14 passed by the National Assembly on November 26, 2019, as amended and supplemented by Law No. 56/2024/QH15 dated November 29, 2024;

- The current Charter of the Company, as amended and supplemented from time to time (the “Charter”);

- The Resolution of the 2026 Annual General Meeting of Shareholders of the Company No. 01/2026/NQ-ĐHĐCĐ dated April 24, 2026; and

- The Resolution of the Board of Directors No. 08./2026/NQ-HĐQT dated 01./06./2026 approving the implementation of the share issuance plan under the Employee Stock Ownership Plan.

3. DEFINITION:

- “**ESOP Program**”: means the Company’s share issuance program conducted directly to employees in accordance with this Regulation.

- “**Employees**” or “**CBNV**”: means employees and staff members of the Company and the Company’s subsidiaries.

- “**ESOP Participant**”: means an employee who has been selected and has completed the purchase of shares under the ESOP Program.

- “**BOD**”: means the Board of Directors.

- “**GMS**”: means the General Meeting of Shareholders.

- “**Group**”: includes the Company and the Company’s subsidiaries.

- “**Company**”: means Masan MEATLife Corporation.

4. ESOP PROGRAM DETAILS:

4.1. Principles of the ESOP Program:

- Employees participating in the ESOP Program shall do so on a completely voluntary basis and shall have the rights and obligations set out in this Regulation.

- Source of shares for the ESOP Program: issuance of 4,792,571 new shares, equivalent to a total par value of VND 47,925,710,000.
- Type of shares applicable to the ESOP Program: ordinary shares.
- Transfer restriction: all shares issued under the ESOP Program shall be subject to a transfer restriction for a period of 01 year from the completion date of the issuance (being the completion date of collection of payment from employees) in accordance with the Government's Decree No. 155/2020/NĐ-CP dated December 31, 2020..

4.2. Eligible Participants of the ESOP Program: Employees of the Company and its subsidiaries who have demonstrated outstanding achievements, made exceptional contributions to the production and business activities of the Company and its subsidiaries, and generated long-term growth value for the Company and its subsidiaries..

4.3. Rights and Obligations of ESOP Participants:

- To enjoy the rights and perform the obligations in accordance with applicable laws and the regulations, rules, and policies of the Company.
- To fully perform all obligations of an ESOP Participant.
- To commit to making best efforts to achieve assigned targets and continuously improve the effectiveness of the work performed for the department in which the ESOP Participant is employed.
- To perform other obligations in accordance with applicable laws and the regulations of the Company.

4.4. Rights and Obligations of the Company:

- To be responsible for issuing ESOP shares to the approved eligible participants and in the approved quantities.
- To disclose information on the issuance and report the implementation results of the ESOP Program in accordance with applicable regulations..

4.5. Share Allocation Criteria to each Employee:

The number of ESOP shares distributed to each employee is based on the following criteria:

- Criteria 1: Contribution to the development of the Company and its subsidiaries;
- Criteria 2: Assigned responsibilities and workload;
- Criteria 3: Results of completing work of departments and individuals;
- Criteria 4: Position;
- Criteria 5: Salary; and
- Criteria 6: Rank.

4.6. Principles and Criteria for Determining the Number of Shares Allocated to Each Employee:

The distribution of ESOP shares is carried out according to the following principles:

Principle 1: Distribution of shares according to 04 groups of employees, including:

- Group 1: The group of employees who bring value to shareholders including business efficiency, strategic initiatives and capital mobilization for the Company and its subsidiaries.
- Group 2: Employees with business development initiatives including building long-term partnerships with investors, allocating capital effectively, managing risk, investing in strategic business areas, and promoting talent; introducing new product development innovations and bringing positive effects; technological innovations and initiatives, helping to improve products and improve production efficiency.
- Group 3: Group of employees who concurrently hold other working positions in the same company in the Group or at two or more companies in the Group.
- Group 4: The group of employees who have participated in each specific project in the previous year.

Principle 2: In each group of employees classified according to principle 1 above, the number of shares allocated to each employee is determined according to the following criteria:

- Group 1: The number of shares distributed to each employee in Group 1 is calculated based on 5 criteria::

- The Company's Business Result Ratio (Criteria 1):

Failure to meet the Business Plan	Up to 0.65
Achieving a low-level business plan	0.65 – 0.8
Within the framework of the business plan at the low and high level	0.8 – 0.9

- Coefficient of departmental work completion results (Criteria 3):

- Rank coefficient, including position, salary and rank (Criteria 4,5,6):

- Work coefficient (Criteria 2, 3): is a coefficient that shows the nature of the work (assigned responsibilities and the amount of work in charge), the results of the individual's contribution to the development of the Company and its subsidiaries, the importance of each employee to the results and efficiency of completing the work of the department and the business results of the Group in 2025.

Nature of work, level of contribution, importance	Job Factor (d)
Less important	0.1 – 0.45
Important	0.45 – 0.9
Very important	>0.9

- Coefficient of individual work completion results (Criteria 3):

Note: For employees who have worked for less than 6 months, the KPI coefficient will be divided by 2.

Employees who successfully complete their work, exceed the plan, and bring significant contributions to the development of the Company and its subsidiaries will be distributed an additional amount of shares as follows (Criteria 1):

Exceeding the KPI plan with a coefficient of 1.05 - 1.09	150,000

Exceeding the KPI plan with a coefficient of 1.2 - 1.24	300,000
Exceeding the KPI plan with a coefficient of 1.25 - 1.29	350,000

Formula for calculating ESOP shares of each person in this group: Based on 05 criteria mentioned above, the shares purchased by each employee are determined according to the following formula (rounded):

$$ESOP_i = \text{Maximum total ESOP shares} \times (a) \times (b) \times (c) \times (d) \times (e) + (g)$$

In which:

- ESOPi: The number of ESOP shares of the employee (i) is entitled to buy
- Maximum total number of ESOP shares: is the total maximum number of ESOP shares issued approved by the General Meeting of Shareholders, equal to 5,104,752 shares.
- (a): Business result coefficient of the member company where employee (i) works
- (b): It is the coefficient of the work completion result of the employee's department (i)
- (c): It is the rank coefficient of the employee (i)
- (d): It is the work coefficient of the employee (i)
- (e): It is the coefficient of the Employee's individual work completion result (i)
- (g): Number of shares Employee (i) will be distributed due to excellent completion of work in 2025.

To ensure that the number of issued shares does not exceed the number of shares allowed to be issued, the number of ESOP shares of each person in this group will be rounded down to the unit row.

- Group 2: The number of shares distributed to each employee in Group 2 is calculated based on 3 criteria:
 - Business development initiative efficiency,
 - Position rank coefficient,
 - Individual contribution coefficient.

This time, the Company did not issue ESOP shares to this group.

- Group 3: The number of shares distributed to each employee in Group 3 is calculated based on 3 criteria:
 - Part-time position multiplier,
 - Part-time time coefficient,
 - The coefficient of the individual's work results.

This time, the Company did not issue ESOP shares to this group.

- Group 4: The number of shares distributed to each employee in Group 4 is calculated based on 3 criteria:
 - Project efficiency coefficient,
 - Position rank coefficient,
 - Individual contribution coefficient.

This time, the Company did not issue ESOP shares to this group.

The formula for calculating ESOP shares and the principle of determining the number of issued shares of each employee:

- **The maximum number of ESOP shares issued** by employees is the total number of shares that employees are issued in each group.

After allocating shares according to the standards, principles and criteria in this Regulation, depending on the important nature of the position and personnel capacity, the Board of Directors will balance and adjust the number of final ESOP shares allocated to employees if necessary.

4.1. Amendment of Regulation:

- The BOD of the Company shall have the authority to adjust, amend, supplement, or replace the Regulation of the ESOP Program in accordance with applicable laws and the actual circumstances of the Company and its subsidiaries.
- In the event that new legal regulations relating to the issuance of shares under an Employee Stock Ownership Plan are promulgated, this Regulation shall be amended accordingly to ensure compliance.
